ANNOUNCEMENTS

- REQUEST FORMS:** Cadets are to fill out the "Request Form" for many purposes;
 - to be excused from Sunday evening training, or a parade,
 - to exchange uniform parts,
 - to switch duty watches with another cadet and more...

Ask your Divisional Officer for help when filling out the request form.

- CIVILIAN CLOTHING:** Cadets can only wear civilian clothing if they do not have a uniform, or if they need to exchange a uniform part. The civilian clothing must be clean and presentable. Jeans and t-shirts are not acceptable.

3. **MARKS OF RESPECT:** Remember to salute the Officers. Remember to respond “Sir” or “Ma’am” after speaking with an Officer. Remember to respond “Chief” or “PO” after speaking with a Petty Officer. You will be reminded if you forget!
4. **DIVISIONAL SYSTEM:** If you have any questions or problems, who do you ask first? The “Divisional System” says that you would ask your *Divisional Petty Officer (DPO)* first. If your DPO cannot help, he/she will ask the *Divisional Officer (DO)*. Your request or question may go as high up as the Commanding Officer if no one else can answer it, but usually your DPO or DO will help you out. Don’t be afraid to ask questions, but ask the right person first!
